# Europe in the 'Asian century': the aspirational chord

- Historical ties important despite colonialism
- Common interest to foster stronger economies ties
- Both regions run on 'Smithian' growth models
- Common interest in broaching a multipolar world; beyond U.S. hegemony or Great Power leadership
- Soft power rather than hard power



#### Europe in the 'Asian century': the realist chord

- No real geostrategic interest in each other
- Source of neither inspiration nor irritation
- Trade growth weakened substantially
- Little convergence in areas such as energy, environment and global governance
- Sulky Europe, but its relative economic decline has yet to really hit home
- Asia's economic power is growing, but no idea how to deploy it




### Trade and commercial policy

- Asia keeps globalising Europe is deglobalising




#### KOF Index of globalisation - Asia








#### Trade between Asia and Europe

- Cyclical factors behind trade stagnation?
- Yes! But: doesn't 1) explain decline in EU exports to Asia, and 2) cyclical factors will not recover
- A. Low growth and aging population in Europe mute demand for imports
- B. Asia is going through a growth deceleration
- Important structural shift in Asia's trade: growing pattern of proximity




#### Share of EU imports





#### Share of Asia's imports



#### Destination of Asia's exports




#### Asia-Europe trade policy

Asia/Asia-Pacific initiatives like the TPP: no comparable initiative involving Europe

EU does not currently have a strategy that realistically can defend its trade position in Asia

### Asia-Europe FTAs

- Asia/Asia-Pacific initiatives like the TPP: no comparable initiative involving Europe
- EU FTAs with Korea and Singapore: insiginificant effect
- EU-ASEAN: dead
- EU-Malaysia: dormant
- EU-India: dormant
- EU-Japan: struggling
  - (EU-China): aspirational



## Why initiatives are failing

- Reform complacency in many Asian and European countries
- Climate of ideas turning against markets in Europe
- Modern trade agreements require improvements in institutions
- Diverging interests in Europe

#### Conclusion

- No intimacy in Asia-Europe political relations
- Trade is central to the relation, but trade is stalling
- Structural factors will keep trade growth weak
- FTAs can help but only at the margin
- Prospects of concluding FTAs are grim
  - TPP will have trade-divertive effects on Europe
